**TO THE HONORABLE LETITIA Z. CLARK,
UNITED STATES BANKRUPTCY JUDGE:**

COME NOW, Eagle Broadband, Inc. (“EBI”) and its eleven wholly-owned Subsidiaries¹
(collectively with EBI, the “Debtors”) and file this Motion for Expedited Consideration of Their
Emergency Application for Authority to Employ Auctioneer to Sell Property of the Estate Free
and Clear of all Interest, Liens or Encumbrances Pursuant to 11 U.S.C. § 363(f) (“Motion”) and
in support thereof would show the Court as follows:

¹ “Subsidiaries” when used herein means Atlantic Pacific Communications, Inc.; Clearworks Communications, Inc.; Clearworks Home Systems, Inc.; Clearworks.Net, Inc.; DSS Security d/b/a Eagle Broadband Security; Eagle Broadband Services, Inc.; EToolz, Inc.; Link-Two Communications, Inc.; Northpointe Telecom Services, LLC; UCGI Corporation; and United Computing Group, Inc.

RELIEF REQUESTED

1. Simultaneously herewith, Debtors requested that the Court grant it authorization to employ an auctioneer to sell office furniture no longer needed by the Debtors. The funds from the sale will facilitate the moving expenses of the Debtors to their new office location which reduces the Debtors' rent expenses by approximately 75%.

2. Debtors move for expedited consideration of their application to employ auctioneer so that the auction may occur prior to the end of the month. Conducting the auction by end of the month will avoid expenses for moving the furniture due to vacating the premises to reduce overhead. In addition, the proposed auctioneer advises that office furniture garners a higher price when sold in an office setting.

WHEREFORE, PREMISES CONSIDERED, Debtors, pray that the Court enter an order granting expedited consideration of their Emergency Application for Authority to Employ Auctioneer to Sell Property of the Estate Free and Clear of all Interest, Liens or Encumbrances Pursuant to 11 U.S.C. § 363(f) and granting all other and further relief to which the Debtors may be justly entitled.
